This week Sam Belamide on behalf of the Project signed a contract agreement with the New Zealand High Commissioner to Solomon Islands Her Excellency Georgina Roberts. . The signing pave the way forward for the construction of a small jetty and upgraded market at Munda in Western Province, CAUSE will use New Zealand's support to procure materials, and use its own funding to employ local workers to construct the jetty. For some time now, the community has identified the need for a small boat jetty as currently there is no public jetty and the existing wharf is dangerous for small craft occupants to navigate. Similarly, the existing

market is rundown and small resulting in vendors establishing makeshift stalls and overcrowding of the wharf area. More than 60 vendors who will be able to access the rehabilitated market once completed .

Literacy training for Verava community.



Verava in Kogulai of Guadalcanal next week will attend a one week literacy training for the community. The training will be conducted by the Literacy Association of Solomon Islands. The training will be covering listening and reading skills. Training is gear towards preparing participants to enter ISDT training. A similar training was conducted in the past and those who have participated were successfully enrolled into ISDT training. Some of the participants who have attended the literacy training were pleased with what they have learnt. Some said had it not the training they wont be able to write their name. Others said the training has opened up their minds and be able to put into practice what they have learnt both from literacy and ISDT trainings. Similar trainings will be conducted in other communities in the coming weeks and months.

Noro market footpath in Progress



The Noro market footpath is progressing very well. Last week contractors completed the first lane on the left side towards the main entrance. Alotaa school footpath in Auki is progressing well. The 166 meters footpath is aim at improving the school surrounding but also access to classes. Alotaa school often face a challenge of water musing up as the school is located in a swampy area. Once the footpath is complete it will surely help the students and teachers in many ways.
